HB 103, Jonathan Carroll (D-Northbrook), prohibits anti-Semitism in government schools.

HB 152, Joe Sosnowski (R-Rockford), requires that a sex offender's residence and place of employment be placed on the Statewide Sex Offender Database.

HB 217, Adam Niemerg (R-Teutopolis), "In God We Trust" can be displayed inside or outside school buildings.

HB 261, HB 1894, HB 2980, HB 3049, SB 133, Charles Meier (R-Highland), Amy Elik (R-Alton), Tom Morrison (R-Palatine), and Adam Niemerg (R-Teutopolis), Terri Bryant (R-Murphysboro), respectively, Ultrasound Opportunity Act offers a woman seeking an abortion after 8 weeks gestation an opportunity to view an ultrasound of her unborn child.

HB 338, HB 3050, Mark Batinick (R-Plainfield) and Adam Niemerg (R-Teutopolis), respectively, provides that a child born alive as the result of an abortion be fully recognized as a human person and accorded immediate protection under the law.

HB 401, Martin Moylan (D-Des Plaines), prevents persons who hold an interest in a publicly traded cannabis company from obtaining a business license to sell cannabis.

HB 402, Martin Moylan (D-Des Plaines), requires ownership information of applicants, registrants or licensees of cannabis businesses and cultivation centers be posted on the web site of agencies responsible for licensing.

HB 622, Steven Reick (R-Woodstock), prohibits the Joint Committee on Administrative Rules (JCAR) from approving Illinois State Board of Education unfunded mandates unless approved by joint resolution of the General Assembly.

HB 780, Patrick Windhorst (R-Harrisburg), requires sex offender registration for video-taping or live video transmission.

HB 783, Patrick Windhorst (R-Harrisburg), repeals tax-payer funding of abortion.

HB 791, Patrick Windhorst (R-Harrisburg), bans abortion after 20 weeks except in a medical emergency.

HB 827, Adam Niemerg (R-Teutopolis), bans partial birth abortion.

HB 1893, Amy Elik (R-Alton), repeals Reproductive Health Act – most extreme abortion law in the nation.

HB 1902, Deanne Mazzochi (R-Westmont), requires a valid ID or a voter identification card if voter signature does not match the voter rolls.

HB 1973, Chris Miller, (R-Robinson), requires a valid ID or voter ID card to vote.

HB 2445, HB 2599, HB 2994, HB 3007, CD Davidsmeyer (R-Jacksonville), Ryan Spain (R-Peoria), Adam Niemerg (R-Teutopolis), and Tom Morrison (R- Palatine), respectively, requires voter ID card or photo ID to vote.

HB 2462, HB 2598, Deanne Mazzochi (R-Westmont) and Ryan Spain (R-Peoria), respectively, requires county clerks to cancel the voter registration of any voter who has died during the preceding month.

HB 2600, Ryan Spain (R-Peoria), an appointed 3-judge panel in each election authority shall compare signatures of voters submitting vote by mail ballots.

HB 2601, Ryan Spain (R-Peoria), requires election authority to record number of vote by mail ballots before, on, and after election day.

HB 2602, Ryan Spain (R-Peoria), requires election authority to report totals of methods of voting within 22 days after election.

HB 2935, Chris Bos (R-Lake Zurich), requires policy be instituted regarding chain of command for mail-in ballots; destroy ballot if someone also votes in person; reporting requirements for number of mail-in ballots received, rejected or destroyed due to in-person voting; and creation of a public database.

HB 3042, Adam Niemerg (R-Teutopolis), restricts the governor from prohibiting or restricting in-person religious services.

HB 3043, HB 3046, HB 3047, HB 3053, Adam Niemerg (R-Teutopolis), repeals Reproductive Health Act — the nation's most extreme abortion law.

SB 54, Terri Bryant (R-Murphysboro), allows an elector from a congressional district to cast their ballot for the presidential candidate that received the most votes in that congressional district; and 2 electors at large can cast their ballot for the presidential candidate that received the highest number of votes in the state.

SB 2038, Darren Bailey (R-Louisville), hand-marked voting ballots only; implement strict chain of command procedures for ballots, voter registration polls, and tabulation results; implement software that monitors and detects vulnerabilities to the security of the voter registration rolls.

HR 6, Jonathan Carroll (D-Northbrook), declares Holocaust Education Week.

HJRCA 1, Anthony DeLuca (D-Chicago Heights), term limits of no more than 3 terms for members of the Illinois House and Senate; applies to only members elected after the adoption of the amendment.

HJRCA 3, Mark Batinick (R-Plainfield), term limits of no more than 12 years in office for Illinois House and Senate members; applies to members who were elected prior to the adoption of the amendment, but are allowed to finish their term.

SJRCA 1, Dan McConchie (R-Lake Zurich), allows for a citizen-initiated petition, signed by at least eight percent of the total votes cast for candidates for Governor in the preceding gubernatorial election, to propose an amendment to Article IV of the Illinois Constitution, which pertains to the legislative body in the General Assembly.

SJRCA 3, Dan McConchie (R-Lake Zurich), amends the Illinois Constitution by providing for a recall of any elected official.

HB 9, Jennifer Gond-Gershowitz (D-Glenview), allows for gender change on a birth certificate when a person undergoes treatment for gender transition.

HB 24, Maurice West (D-Rockford), mandates sex ed curriculum include discussions on sexting for 6th -12th grades, introducing young children to more devious sexual behavior.

HB 79, Mary Flowers (D-Chicago), schools "must include instruction on the medical and legal ramifications of cannabis use." Because it's legal for recreational use and has dozens of "medical" uses with intent to include more, instruction could potentially nudge children into experimentation, believing that medicine doesn't hurt them.

HB 80, Mary Flowers (D-Chicago), mandates students read nonfiction and fiction books about racism in grades K-12, some of which are filled with hate and are sexually explicit.

HB 135, Michelle Mussman (D-Schaumburg), allows pharmacists to dispense hormonal contraceptives by way of a standing order from the Director of Public Health; mandates health insurance policies to cover the contraceptives.

HB 144, Sonya Harper (D-Chicago), licenses to allow consumption of marijuana at temporary events, clubs, or tours.

HB 193, Sonya Harper (D-Chicago), home delivery of marijuana.

HB 309, LaToya Greenwood (D-East St. Louis), creates the Implicit Bias Training for Health Care Professionals Act. A licensee shall complete implicit bias training regarding "race, ethnicity, gender, identity, sexual orientation, socioeconomic status, or other characteristics."

HB 715, Sonya Harper (D-Chicago), permits people to bring their own marijuana to any place open to the public.

HB 724, Curtis Tarver (D-Chicago), gives all General Assembly members authority to arrest anyone who break the peace or violates any municipal ordinance or criminal law of the State.

HB 1736, by Kathleen Willis (D-Northlake), sets forth comprehensive sex ed requirements for pre-K through 12th grade.

HB 1797, SB 2190, Anna Moeller (D-Elgin) and Elgie Sims (D-Chicago), respectively, repeals Parental Notice of Abortion Act.

HB 1871, HB 1873, Katie Stuart (D-Collinsville) and Carol Ammons (D-Urbana) respectively, provides collection sites for vote by mail ballots; provides early and election day curb-side voting, requires all vote by mail ballots be accepted with or without postage.

HB 2590, SB 139, Ann Williams (D-Chicago) and Sara Feigenholtz (D-Chicago) respectively, allows people to change their gender or request a non-gendered marriage license.

HB 3071, Camille Lilly (D-Oak Park), expansive changes to what comprehensive sex ed programs must include.

HB 3085, Mary Flowers (D- Chicago), expunges all criminal history for possession or delivery of cannabis after January 1, 1970; releases all prisoners from incarceration if solely convicted on cannabis charges.

HB 3769, Rita Mayfield (D-Waukegan), beginning October 1, 2021, Culturally Responsive Teaching Standards shall apply to all professional educator licenses, school support personnel, administrative fields, candidates for licensure and educator preparation programs.

SB 457, HB 3195, Melinda Bush (D- Grayslake) and Katie Stuart (D- Collinsville), respectively, creates all-gender multiple-occupancy bathrooms.

SB 647, Ram Villivalam (D-Chicago), creates a comprehensive sex ed program from K-12th regarding consent, pregnancy, STDs, gender identity. Parents can opt out.

SB 1565, Celina Villanueva (D-Summit), creates a voter registration affidavit for illegal aliens to vote in a school board election.

SB 1596, Jacqueline Collins (D-Chicago), establishes that a criminal act against a person based on their actual or perceived citizenship or immigration status is a hate crime.

SB 1631, SB 2569, Steven Landek (D-Burbank) and Melinda Bush (D-Grayslake), respectively, allows voters to permanently receive vote by mail ballots.

SB 1992, Ram Villivalam (D-Chicago), expands early voting polling places from the 15th day before an election to the 22nd day before an election; requires certain polling places to be open 16 hours per day on the final weekend.

SB 2136, Jacqueline Collins (D-Chicago), expungement of ALL criminal felony prostitution charges; provides post-conviction relief.

SB 2227, Doris Turner (D-Springfield), allows person who is 16 (not 17) to preregister to vote on or after their birthday and registration will be held in abeyance until they are eligible to vote.

SB 2342, Kimberly Lightford (D-Hillside), instant win Lottery games through the Internet.

SB 2404, Napoleon Harris (D-Dolton), 200 licenses for "medical cannabis dispensing organizations" to deliver to homes of registered medical cannabis patients and caregivers.

HR 39, sponsored by Michelle Mussman (D-Schaumburg), a resolution in support of comprehensive sex education in government schools. ■
